

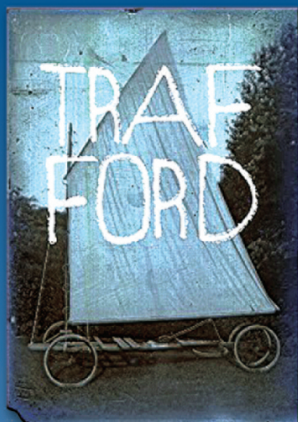

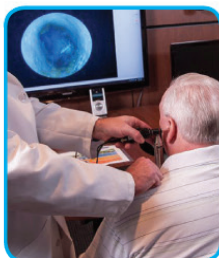

The 14.5-mile paved trail runs along Narragansett Bay and connects eight parks along its route. Power vehicles are not permitted.

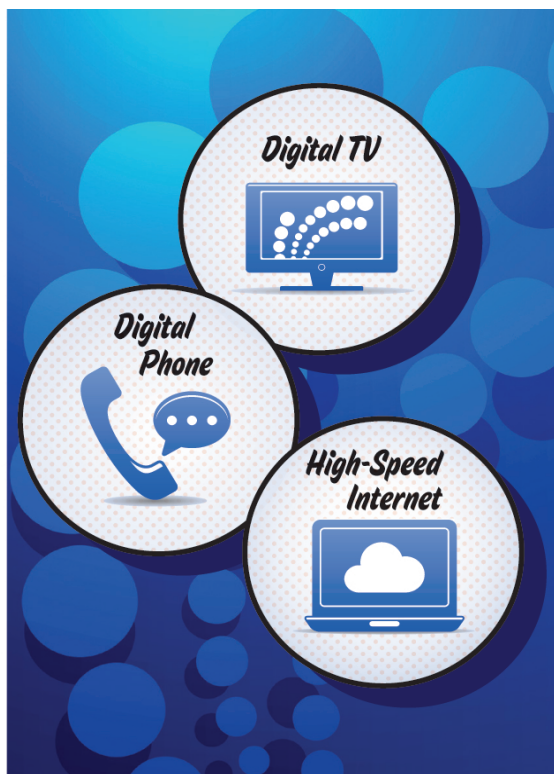

Barrington

Located on the east shore of Narragansett Bay, 10 miles southeast of Providence via U.S. 95 and 195. (195 connects with R.I. 114, which becomes County Road at the White Church bridge, Main St. in Warren, and Hope St. in Bristol). No point in Barrington is more than two miles from salt water.

Land Area: 8.9 sq. miles
Water Area: 7.0 sq. miles

Barrington is best known today as a place of beautiful homes, country estates, tree-lined streets and a boat-filled harbor. In 2005, the town was named as the sixth best place to live in the United States by Money Magazine. Originally, Barrington was part of Sowams, the residence of Massasoit, chief of the Wampanoag Indians. In 1653, Gov. William Bradford and others bought the area between

Narragansett Bay and the Taunton River from Massasoit. In 1673, this area was incorporated under the name of Swansea as part of the Plymouth Colony. Barrington was set off as a separate town in the Commonwealth of Massachusetts in 1717.

In 1746, by royal decree, the town was made part of Rhode Island, together with Bristol, Tiverton, Little Compton and Cumberland. In 1747, the name was changed to Warren in honor of Sir Peter Warren of the British Navy. Barrington was taken from Warren and incorporated as a separate town on June 16, 1770.

In the early days, Barrington was a farming community and in the 19th century it became popular as a summer resort. Memorabilia from the earlier way of life may be seen at the Barrington Preservation Museum. At the Allin and Tyler Point cemeteries, residents and

Community Guide

Bristol

The southernmost town in Bristol County is easily accessible from Rt. 114 and 136, which connects to U.S. 195 and Rtes. 24 and 138 on Aquidneck Island.

Land Area: 10.1 sq. miles
Water Area: 10.5 sq. miles

Located on Narragansett Bay, Bristol was the site of the first battle of King Phillip's War in 1675. This was a rebellion by Wampanoag natives against settlers who bought land from King Phillip's late father, Massasoit. As a result of the war, Plymouth Colony in Massachusetts retained Bristol lands, finally releasing them, together with the towns of Barrington, Tiverton, Little Compton and Cumberland in 1747.

Sailing and shipbuilding have played an important role in the life of Bristol since the

17th century. In the 1700s Bristol was a major port for the slave trade and later privateering flourished. During the American Revolution, the Joseph Reynolds House on Hope St. served as headquarters for the Marquis de Lafayette and his staff in 1778.

Today, Bristol remains a center of history with many handsome homes built in the 1700s and 1800s, some designed by noted architect Russell Warren, gracing the tree-lined st.s. Visitors come from far away to enjoy Bristol's Fourth of July parade (the oldest 4th of July celebration in America), stroll along its waterfront, shop in its many stores and dine in its fine restaurants.

Located in the center of Bristol County and bordered by Bristol on the south and Barrington on the north. It is accessible from R.I. 114 and 136 which connect to U.S. 195.

Warren is the smallest community in the smallest county in the smallest state, and has grown from a settlement of 18 houses in 1653 to a community with a population of 11,360 within its 6.2 square miles.

Incorporated into Rhode Island from Swansea, Mass., in 1747, Warren was named for Sir Peter Warren who commanded the British fleet that cooperated with New England troops in capturing the fortress at Louisberg.

After the Revolution, shipbuilding, maritime trades and whaling flourished. The ethnic diversity found here today stems from those who came to work in the mills in the late 19th and early 20th centuries including French-Canadians, Italians, Polish, Irish and Portuguese.

The College of Rhode Island (now Brown University) was founded in Warren in 1746 and held its first commencement in town before relocating to Providence.

Antiquing has been emerging as a major draw for tourists and residents alike, in small shops along Water, Main and Child streets.

Warren is also home to an eclectic arts scene, displayed in events such as the ones held by Art Night - Bristol & Warren, where visitors can explore galleries and open studios.

The Warren River borders the historic downtown area and is home to the Blount Shipyard and Blount Seafood. The annual Warren Quahog Festival offers fresh cooked seafood, chowder, stuffed quahogs and clam cakes, along with arts and crafts and musical entertainment.

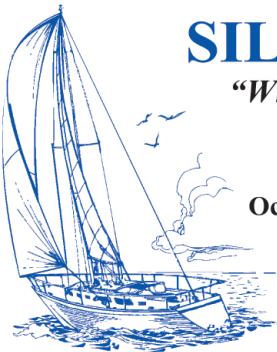
